MWCR recognizes that many volunteers/members have families and jobs and can devote only a limited amount of time to volunteer activities.

A volunteer/member is someone who may serve in various capacities acceptable to the volunteer and assigned at the discretion of the board of directors. Volunteers/members agree to abide by MWCR's mission, bylaws, and policies and procedures; to abide by confidentiality requirements; to treat other volunteers/members, including the board, courteously and with respect at all times; and to conduct themselves professionally in all contacts on behalf of MWCR. Volunteers/members may not contact individuals or groups on behalf of MWCR without express written approval of the board of directors, and may not obligate MWCR in any way except with the board's approval.

Members agree to maintain confidentiality of all private and/or proprietary information related to MWCR and/or volunteer members. Failure to abide by this agreement and by MWCR's policies and procedures and bylaws, or actions such as misconduct, insubordination, or refusing to perform agreed-upon functions, may result in termination of membership.
